The Board of Education of Dunlap CUSD 323, Dunlap, Illinois is seeking qualified applicants for the position of Superintendent. The Board wishes to select a superintendent who will begin work on July 1, 2027.

The Board expects to offer a salary in the range of **\$180,000 to \$230,000** and a competitive benefits package including sick leave, vacation days personal days, health insurance, dental/vision insurance, life insurance, TRS/THIS contributions, and professional membership dues. It is anticipated that the total compensation package will be based on successful experience and education. It is expected that the initial contract will be for a multi-year period, as authorized by Illinois statutes.

The district is in its eighth year of its 1:1 technology program and is implementing an artificial intelligence policy and guidance for teacher and student use to ensure students continue to be future-ready.
